What do I need to know about e.Notifications, e.Statements, and 1099 e.Notifications?

#### i.Teller Users

- 1. i.Teller users will automatically be enrolled in e.Statements.
- 2. You can choose to enroll in e.Notifications to receive electronic notices for overdrafts/non-sufficient funds, loan delinquency, CD maturities, and 1098 mortgage interest statements.

- 3. Paper CD maturity notices will continue to be sent, if you do not sign up for e.Notifications.
- i.Teller users will also be automatically enrolled in electronic 1099 interest statements.

#### Non-i.Teller Users

- 1. You will continue to receive paper CD maturity notices, paper statements and paper 1099 interest statements.
- Beginning March 16, 2015, you will no longer receive paper notices for overdrafts/non-sufficient funds, loan delinquencies, or 1098 mortgage interest

## Shared Branch Fee Change

Effective March 15, 2015, there will be a small fee of \$3.00 for the use of Shared Branch transactions. A Shared Branch is a branch owned and operated by another credit union which serves  $\mathbf{M}$  members with certain transactions.

The great news is that your M offers alternatives to shared branches that are free and easy to use!

#### Make a loan payment

- Sign up for Auto Pay so the payment pulls from your M account every month. This form can be completed over the phone by calling M.
- Make a simple transfer from your i.Teller checking or savings account to your M loan account. This transfer makes an instant payment. Transfers can be set up to reoccur or happen just one-time.

#### **Deposit a Payroll Check**

- ullet Set up direct deposit, which can be done right over the phone by calling M. The full check amount will automatically be deposited and available immediately.
- Utilize an M ATM after hours to deposit a check. At an M ATM up to \$800 of your check would be made available immediately.

A \$10 monthly Dormant Account Fee applies to Primary Savings of \$100 or less, with no member activity for two years (other than interest paid), with no other account relationships, when owner is age 18 or older.
